Dated, Bhubaneswar the 24-6-91

No. NGE-R-13/91 - 20293 /Ag., Hither-to outsiders are being recruited as VAW trainees to undergo pre-service training in Agriculture Science and Extension for a period of one year at the G.S.T.Ks with a stipend of Rs.100/-P.M. in accordance with the provisions laid down in the "Recruitment and Training of VAWs Rules 1981 - vide Notification No. NG-II-Extn-4/81-5528/AC dated 11.2.81 of A&C Department. After successful training such candidates are appointed as VAW/LVAWs against the available vacancies in the scale of Pay as sanctioned by Government from time to time.

2. After careful consideration Government have now been pleased to decide that, henceforward, candidates will be recruited against the vacancies in the post of VAW/LVAW on provisional basis in the prescribed scale of pay as sanctioned by Government from time to time, thereafter they will undergo in-service training at the G.S.T.Ks or at such other places as Government may decide. Their regular appointment as VAW will depend on their successful completion of the said training. In the event of failure on the part of any provisional appointee to come out successful in the training, he/she will lose his provisional appointment.

3. The Recruitment and Training of VAWs Rules 1981 stand modified to the above extent.

4. This will come into force from the date of issue.
