Sub: Arrangement for **telephone, Vehicle, Staff etc.** for the State Farmers' Commission.

The State Farmers' Commission has been constituted vide Govt. Notification No.52 dated 02.01.2010.

2. To facilitate effective functioning of the State Farmers' Commission the following arrangements have been made:-


- (i) The Commission shall hold office in IMAGE premises.
- (ii) The Chairman of the commission shall be provided with a Private Secretary, Two peons and a Telephone with STD facilities for his Office. The Chairman shall be provided with a hired vehicle for his conveyance.
- (iii) The members of the commission shall be provided with a personal Assistant. Each member shall be provided with one peon and telephone with STD facilities for their office. The members shall be provided with a hired vehicle each for their conveyance.

However vehicle, telephone and supporting staff will not be made available to the member Dr. Niranjan Panda and member-convenor, Sri D.P Ray of the Commission, since they are holding the post of the Chairman, Western Orissa Dev. Council and VC, OUAT respectively.

- (iv) Whenever the Chairman, Members and Member- Convener of the commission shall undertake tours to the District / Field, the vehicles as per the requirement may be hired from the Travel Agents. The hire charges of the hired vehicle shall be borne by the State Farmers' commission.
- (v) One IAS/OAS offices in the rank of Additional Secretary/ Joint Secretary will be appointed as Secretary to the State Farmers Commission. One Section Officer, two Assistant section officers, two computer operators and two peons will be deputed/deployed to the State farmers' commission.


(vii) The O.E. Branch will take appropriate steps for accommodation, furnishing and supply of furniture, fixtures and stationeries etc. and installation of Telephone in the Farmers' Commission.

This will come into effect from 1<sup>st</sup> ~~February~~ <sup>March</sup>, 2010.




