Applications are invited from interested retired officers in the rank of Law Officer / retired OSS /retired ORS/retired OAS/retired Odisha Legal Service officers well versed with court cases and legal matters for contractual engagement as Legal Consultant in the Department of Agriculture & FE against the vacant post of Asst. Law Officer in accordance with GA & PG Department Resolution No. 2370 dated 27.08.2014 & F.D O.M No.7022 dated 17.03.2018.

2. The contractual engagement will be made for a period of one year or till the posts are filled up by the Home Department on regular basis whichever is earlier.

3. The eligibility for appointment of retired employee as Legal Consultant on contractual basis

- a) - should have qualification of Bachelors' Degree in Law from a recognised university or have well versed with experience in dealing Court cases and legal matter.
- b) – should be below 65 years of age and physically fit to discharge his/her duties.
- c) – should have good service records.
- d) – should have no Disciplinary Proceedings or Vigilance Case or criminal cases instituted against him/her during his/her service period.
- e) – should not have been penalized for misconduct during last 5 years of his service or
- f) – should not be a member of a political party

4. The consolidated remuneration of the contractual employee shall be at the rate of Rs.30,000/- per month as per F.D O.M No.7022 dated 17.03.2018.

5. The period of contractual engagement shall not be counted as Govt. service for the purpose of pension and any other retirement benefit.

6. The engaged officer will be subject to and abide by the prescribed Conduct Rule as applicable to the Govt. servant and their re-employment can be terminated at any time by the respective appointing authority due to unsatisfactory performance of any of the re-employed officer by giving one month notice. On contrary, if any re-employed officer desires to resign he shall do so by giving one month's written notice to the competent authority.

7. The applicant will furnish an undertaking at the time of joining the duty in regard to the truth and correctness of the information furnished by him/her. They shall have to furnish the prescribed undertakings and such other documents as may be required.
