Sri Chittaranjan Sahoo, Joint Director of Agriculture (Level-I), now working as Agriculturist, A & FE Deptt is promoted to the rank of Additional Director of Agriculture (Superior Grade) in the Pay Scale of Level-15 of Pay Matrix under ORSP Rules, 2017 on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier.
