
The following Chief District Agriculture Officers (CDAO) or Joint Directors of Agriculture (JDA), Level-II are promoted to the rank of Joint Director of Agriculture, Level-I (Super time Scale) in the pay scale of Level-14 of pay Matrix under ORSP Rules, 2017 (Pre-revised scale Rs. 15,600/- to Rs. 39,100/-, G.P Rs. 7600/- in PB-3) on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier. This adhoc promotion is subject to concurrence of the OPSC on their earlier adhoc promotion to the rank of CDAO/JDA, L-II. If the OPSC do not agree to concur the earlier adhoc promotion of any of the following officers, he will be reverted to the lower grades of the cadre.

Such promotion shall be subject to final outcome of the cases in W.P. (C) No. 16909/2016, 16911/2016, 16622/2016 & 16376/2016.

On promotion they are posted as Joint Director Agriculture, Level-I (Super Time Scale) in the offices noted against each as follows.
