No. DAFE-AFEI-FE-0085-2017- 22491 /Ag&FE, Dated- 14-12-18

Pursuant to the order No.4 dated 29.11.2013 arising out of W.P.(C) No.1549 of 2013 of the Hon'ble High Court of Odisha, the following Assistant Agriculture Officers (Group-B) in Agriculture Service are promoted to the rank of District Agriculture Officer (Group-A, Jr. Grade) on adhoc basis in Level-12 of Pay Matrix under ORSP Rules, 2017 for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officer, whichever is earlier.

Such promotion shall not only be subject to the final result of the Original Application but also if ultimately, the gradation list is quashed, the said promotion shall stand quashed and the State shall take a fresh exercise with regard to preparation of gradation list as per the earlier direction of the learned Tribunal issued on 11.08.2011 in the judgement passed in O.A. No.2276(C) of 2009 and the connected Original Application or any other order to be passed by the Hon'ble Odisha Administrative Tribunal in the Original Application now pending and also subject to the outcome of OA No. 3500/2013.
