In pursuance of provisions contained in the erstwhile Agriculture Department Resolution No.10320/Ag, dated 07.07.2015, the State Government do hereby appoint the following 76 candidates who have been selected by the Odisha Public Service Commission, Cuttack during the year 2016 to the post of Assistant Soil Conservation Officer (ASCO), Group-B in Soil Conservation Service in Pay Band-2 in the Scale of Pay of Rs.9,300 - Rs.34,800/- with Grade Pay of Rs.4,600/- per month plus usual D.A and other allowances as admissible to Government Servants from time to time w.e.f the date he/she actually reports for duty. The appointment is purely temporary and terminable at any time without previous notice and without assigning any reason thereof and subject to verification of character and their antecedents in due course in terms of G.A. Department Resolution No.34438, dated 20.11.1999. In case an adverse report is received his/her services shall be terminated forthwith in accordance with the provisions laid down in sub-clause-II of the Clause-'h' of explanation under Rule-13 of Odisha Civil Services (Classification, Control & Appeal) Rules, 1962. 
