Pursuant to Rule-4(2)(b) of Odisha Agriculture and Food production Service (Method of Recruitment and Conditions of Service) Rules, 2018, the following Agriculture Overseers/VAW (Group-C) are promoted to the rank of Assistant Agriculture Officer (Group-B) in the Level-10 of Pay Matrix of Odisha Revised Scale of Pay, Rules-2017 on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier.




