

Pursuant to Rule-4(2)(c) of Odisha Agriculture and Food Production Service (Method of Recruitment & Conditions of Service) Rules, 2018, the following Agriculture Overseers (Group-C) are promoted to the rank of Assistant Agriculture Officer (Group-B) in the Level-10 of Pay Matrix of Odisha Revised Scale of Pay, Rules-2017 on adhoc basis for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier.






