The following Assistant Soil Conservation Officer (Group-B) in Soil Conservation Service are hereby promoted to the rank of Assistant Director, Soil Conservation (Group-A, Junior Grade) on ad hoc basis carrying the pay at Level-12 of the pay matrix under ORSP Rules, 2017 consistence with the pre-revised Scale of Pay under pay Band-2 (i.e. Rs.9,300 - Rs.34,800/- with Grade Pay of Rs.5,400/-) for a period not exceeding one year or till receipt of the recommendation of the OPSC or till retirement of the officers, whichever is earlier subject to the recommendations of the D.P.C. held on 25.08.2018.


