RESOLUTION

No.AFE-I(A)06/14- 8181 /Ag, Bhubaneswar, dated 20/5/14

Sub: -Deployment of Officers in Odisha Agriculture Service.

Government, after careful consideration, have been pleased to decide the following:-

1. In case of vacancy in the post of Deputy Director of Agriculture (only at the district level), the senior most District Agriculture Officer available in the district will be kept in charge of Deputy Director of Agriculture (DDA) in the same revenue district till the regular vacancy is filled up by way of promotion or until further orders whichever is earlier.
2. Any vacancy in the post of DAOs in the district will be manned by the DAO of the nearby place of the same revenue district as additional charge.
3. The power of deployment of officers at all levels within a revenue district in the exigency of the public work can be exercised by the DA & FP (O), any deployment outside the district be made only with prior approval of the Principal Secretary to Govt.
4. This decision will take effect from the date of issue of the resolution.
