## RESOLUTION

Sub: Restructuring of cadre of Orissa Agriculture Service

The matter relating to restructuring of the Cadre of Orissa Agriculture Service was under active consideration of Government for some time past.

- 2. Government, after careful consideration, have been pleased to decide the following:-
  - (i) The entry level post of the cadre of Orissa Agriculture Service shall be in the rank of Class-II (Group-'B') carrying the scale of pay of Rs.6,500-200-Rs.10,500/- subsequently revised to pay band-2, Rs.9,300-34,800/- plus Rs.4,600/- as Grade pay as per the provisions contained in ORSP Rules,2008.
  - (ii) The up-gradation of posts belonging to Class-II (Group-'B') and Class-1 (Group-'A') in the cadre of Agriculture Service shall be as follows:-
